## CITY OF TORONTO

## BY-LAW No. 760-2001

To layout and dedicate certain land for public highway purposes to form parts of the public highways Havenlea Road, Gramercy Square and Samuel Teitel Court.

WHEREAS the City has acquired certain lands as hereinafter described and the Council of the City deems it appropriate and necessary to accept the said lands as Public Highways; and

WHEREAS subsection 1(a) of Section 297, of the *Municipal Act*, R.S.O. 1990, Chapter M.45 provides that the Council of every municipality may pass by-laws for establishing and laying out highways; and

WHEREAS subsection 111 of Section 210, of the *Municipal Act*, R.S.O. 1990, Chapter M.45 provides that by-laws may be passed by the Councils of local municipalities to provide for surveying, settling and marking the boundary lines of highways and giving names to them.

The Council of the City of Toronto HEREBY ENACTS as follows:

- 1. The lands described as Blocks 107, 108 and 109 on Plan 66M-2277 in the City of Toronto (formerly City of Scarborough), more particularly described in Schedule "A" attached hereto, which forms part of this By-law, are hereby established and laid out as a public highway within the City to be known as Havenlea Road.
- 2. The lands described as Block 114 on Plan 66M-2277 in the City of Toronto (formerly City of Scarborough), more particularly described in Schedule "A" attached hereto, which forms part of this By-law, are hereby established and laid out as a public highway within the City to be known as Gramercy Square.
- 3. The lands described as Block 116 on Plan 66M-2277 in the City of Toronto (formerly City of Scarborough), more particularly described in Schedule "A" attached hereto, which forms part of this By-law, are hereby established and laid out as a public highway within the City to be known as Samuel Teitel Court.
- **4.** All By-laws presently in force with respect to highways and streets shall apply to the said highways created under this By-law.
