BY-LAW No. 838-2001

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,
respecting Boardwalk Drive, Joseph Duggan Road, Northern Dancer Boulevard,
Sarah Ashbridge Avenue, Winners Circle.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By inserting in Schedule IV (Stop Intersections) in § 400-57, the following in alphabetical order by street name:

Northern Dancer Boulevard and Boardwalk Drive	Northern Dancer Boulevard (northbound and southbound)

Winners Circle and Boardwalk Drive	Winners Circle (northbound and southbound)

B. By inserting in Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:
