**CITY OF TORONTO**

**BY-LAW No. 840-2001**

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,  
respecting Lukow Terrace, Norton Avenue, Symington Avenue.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By inserting in Schedule I (One-way Highways) in § 400-54, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)
Lukow Terrace	Wabash Avenue and the terminus of Lukow Terrace	Anytime	From north to south

B. By deleting from Schedule XVIII (Weight Limits on Highways) in § 400-71, the following in alphabetical order by street name:

(From Column 1)	(From Column 2)	(From Column 3)
Symington Avenue	Bloor Street West and Davenport Road	7:00 p.m. of one day and 7:00 a.m. of the next following day

C. By inserting in Schedule XVIII (Weight Limits on Highways) in § 400-71, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)
Symington Avenue	Bloor Street West and Dupont Street	7:00 p.m. of one day and 7:00 a.m. of the next following day
Symington Avenue	Dupont Street and Davenport Road	Anytime

D. By deleting from Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

(From Column 1)	(From Column 2)	(From Column 3)	(From Column 4)
Norton Avenue	North	Dufferin Street and St. Clair Gardens	Anytime
Norton Avenue	South	Dufferin Street and a point 45.7 metres west of it	Anytime

E. By inserting in Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)
Norton Avenue	North	A point 45.7 metres west of Dufferin Street and St. Clair Gardens	Anytime

F. By inserting in Schedule XXIX (No Standing) in § 400-82, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)
Norton Avenue	Both	Dufferin Street and a point 45.7 metres west thereof	Anytime
