**CITY OF TORONTO**

**BY-LAW No. 995-2001**

**To amend the former City of Toronto Municipal Code Chapter 20, Business Improvement Areas, to include the new Liberty Village Business Improvement Area and to establish a Board of Management for the Liberty Village Business Improvement Area.**

WHEREAS Council, at its meeting held on January 30 and 31, 2001 and February 1, 2001 by its adoption of Clause No. 6 of Economic Development and Parks Committee Report No. 1, authorized the designation of an area bordered by the east side of Dufferin Street to the west, Canadian Pacific Limited to the east, the south side of King Street West to the north and Canadian National Railways to the south as a business improvement area under section 220 of the *Municipal Act*; and

WHEREAS by the adoption of Clause No. 3 of Economic Development and Parks Committee Report No. 12 on December 4, 5 and 6, 2001, City of Toronto Council established a Board of Management for the Liberty Village Business Improvement Area and appointed members to the Liberty Village Business Improvement Area Board of Management for a term expiring on November 30, 2003, or as soon thereafter as successors are appointed; and

WHEREAS Schedule A of Municipal Code, Chapter 20, Business Improvement Areas of the former City of Toronto must be amended to include the new Liberty Village Business Improvement Area Board of Management;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. The table in Schedule A of the former City of Toronto Municipal Code Chapter 20, Business Improvement Areas, is amended by adding the new Liberty Village as set out in Schedule A attached hereto.
2. The attached map of the Liberty Village Business Improvement Area is added to the maps section of Schedule A of the former City of Toronto Municipal Code Chapter 20, Business Improvement Areas.
3. The table in § 20-2 of the former City of Toronto Municipal Code Chapter 20, Business Improvement Areas, is amended by inserting in the first column "34-2001" and by inserting in the third column "Liberty Village".

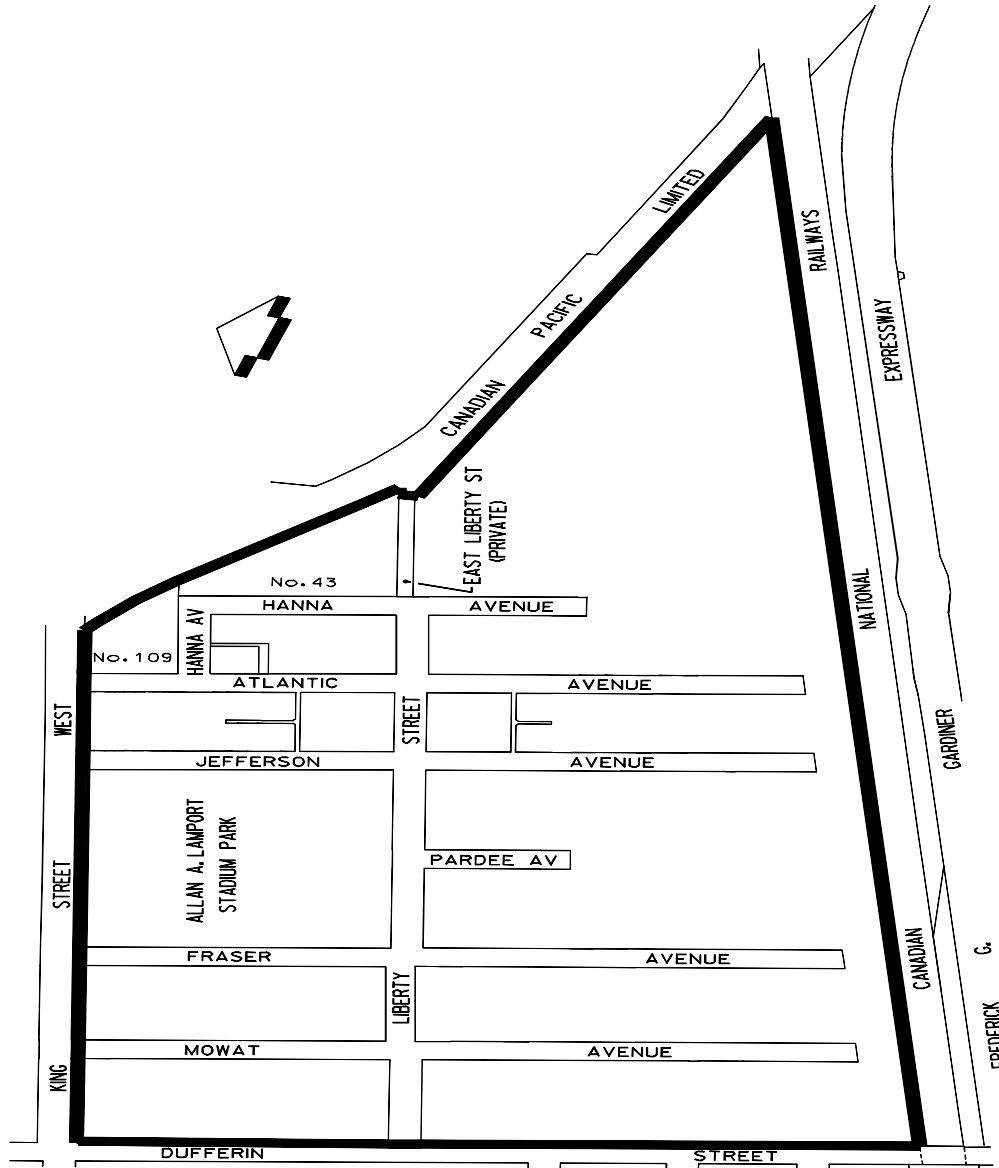
