**CITY OF TORONTO**

**BY-LAW No. 1009-2001**

**To stop up and close portions of the public highways Alcide Street, Codlin Crescent and Steeles Avenue West and to authorize the sale thereof.**

WHEREAS it is recommended that portions of the public highways Alcide Street, Codlin Crescent and Steeles Avenue West be stopped up and closed as public highways and be sold to the abutting owner; and

WHEREAS notice of the proposed by-law to stop up, close and sell the said portions of the public highways was published in the Toronto Sun on October 30, November 6, 13 and 20, 2001 and on November 21, 2001, the Etobicoke Community Council heard any person who claimed that the person's land would be prejudicially affected by the said by-law who applied to be heard;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. The portions of the public highways Alcide Street, Codlin Crescent and Steeles Avenue West, described as follows:

**FIRSTLY:**

Part of PIN 07301-0082 (LT)

Part of Alcide Street on Plan 28, City of Toronto (formerly City of Etobicoke), designated as Part 9 on Plan 66R-19228

Land Titles Division of Metropolitan Toronto (No. 66)

**SECONDLY:**

Part of PIN 07301-0095 (LT)

Part of Steeles Avenue West, also known as Codlin Crescent, being part of the Road Allowance between the Townships of Vaughan and Etobicoke, City of Toronto (formerly City of Etobicoke), designated as Part 11 on Plan 66R-19228

Land Titles Division of Metropolitan Toronto (No. 66)

## THIRDLY:

PIN 03220-0030 (LT)

Part of Steeles Avenue West, being part of Lot 1, Concession 9, City of Toronto (formerly City of Etobicoke), designated as Parts 5 and 6 on Plan 65R-23961

Land Titles Division of York Region (No. 65)

are hereby stopped up and closed as public highways.

2. The soil and freehold of the portions of the public highways stopped up and closed by Section 1 of this By-law shall be sold to the abutting owner on the terms and conditions set out in Clause No. 17 of West Community Council Report No. 3, as adopted by Council at its Regular Meeting held on April 23, 24, 25, 26 and 27, 2001 and its Special Meetings held on April 30, May 1 and 2, 2001.
