BY-LAW No. 1016-2001

To amend By-law No. 31001 of the former City of North York, as amended.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Schedule "VIII" of By-law No. 31001, of the former City of North York, is amended by deleting from Columns 1, 2, 3 and 4 the following:
