## **CITY OF TORONTO**

### **BY-LAW No. 1091-2001**

**To layout and dedicate for public highway purposes certain land to form part of the public highway Alcide Street and to layout and dedicate certain other lands immediately adjacent to the public highway Codlin Crescent for public highway purposes.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Certain land to form part of the public highway Alcide Street, described by W. Kowalenko, O.L.S., City Surveyor, as follows, namely:

**FIRSTLY:**

Part of PIN 07301-0009 (LT).

Parcel 8-1, Section B28.

Part of Lot 8, north side of Albion Road, parts of Lots 10 and 11, west side of Alcide Street, and parts of Lots 12 and 13, south side of Steeles Avenue on Plan 8 designated as PART 1 on Plan 66R-19228

Metropolitan Toronto Land Titles Division (No. 66).

City of Toronto (formerly the City of Etobicoke) and Province of Ontario.

**SECONDLY:**

PIN 03220-0049 (LT).

Part of Lot 1, Concession 9, designated PART 1 on Plan 65R-23961

York Region Land Titles Division (No. 65).

City of Toronto (formerly the City of Etobicoke) and Province of Ontario

is laid out and dedicated for public highway purposes to form part of Alcide Street.

2. Certain land to form part of the public highway immediately adjacent to Codlin Crescent, described by W. Kowalenko, O.L.S., City Surveyor, as follows, namely:

Part of PIN 07301-0106 (LT).

Parcel 8-1, Section B28.

Parts of Lots 10, 11 and 12, north side of Albion Road, on Plan 28, designated as PART 7 on Plan 66R-19228

City of Toronto (formerly the City of Etobicoke) and Province of Ontario.

**FOURTHLY:**

Part of PIN 07301-0009 (LT).

Parcel 8-1, Section B28.

Part of Lots 8 and 9, north side of Albion Road, on Plan 8 designated as PART 5 on Plan 66R-19228

Metropolitan Toronto Land Titles Division (No. 66).

City of Toronto (formerly the City of Etobicoke) and Province of Ontario.

**FIFTHLY:**

Part of PIN 07301-0082 (LT).

Part of Alcide Street on Plan 28 designated as PART 6 on Plan 66R-19228

Metropolitan Toronto Land Titles Division (No. 66).

City of Toronto (formerly the City of Etobicoke) and Province of Ontario.

is laid out and dedicated for public highway purposes.

3. Sections 1 and 2 of this By-law do not come into effect until the conveyances to the City of the lands described in Sections 1 and 2 and the necessary land registrations respecting those conveyances are completed.
