CITY OF TORONTO

BY-LAW No. 1118-2001

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Blackthorn Avenue, Havelock Street, Marion Street, Melbourne Avenue, Moutray Street, Quebec Avenue, St. Clarens Avenue, St. Helens Avenue.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:
 - A. By deleting from Schedule XXXVIII (Designated On-Street Parking for Disabled Person Parking Permit Holders) in § 400-91, the following in alphabetical order by street name:

Moutray Street	North	A point 57 metres west of Sheridan Avenue and a point 5.5 metres further west thereof	Anytime
St. Clarens Avenue	East	A point 22.5 metres south of Dupont Street and a point 5.5 metres further south thereof	Anytime

- B. By inserting in Schedule XXXVIII (Designated On-Street Parking for Disabled Person Parking Permit Holders) in § 400-91, the following in alphabetical order by street name:

Blackthorn Avenue	West	A point 17 metres south of Rockwell Avenue and a point 5.5 metres further south thereof	Anytime
Havelock Street	East	A point 81.4 metres south of Dufferin Park Avenue and a point 5.5 metres further south thereof	Anytime
Marion Street	South	A point 77.5 metres west of Fuller Avenue and a point 5.5 metres further west thereof	Anytime
