**CITY OF TORONTO**

**BY-LAW No. 8-2002**

**To amend Metropolitan Toronto By-law No. 1206, a by-law “To acquire certain easements or rights in the nature of easements for or in connection with the Wilket Creek Sanitary Trunk Sewer”, a by-law of the former Municipality of Metropolitan Toronto.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. By-law No. 1206, a by-law “To acquire certain easements or rights in the nature of easements for or in connection with the Wilket Creek Sanitary Trunk Sewer”, is amended by:
  - (a) the deletion of Schedule “A” attached to By-law No. 1206; and
  - (b) the substitution in place and stead of the said Schedule “A” the schedule attached hereto as Schedule “A.1”.

**SCHEDULE "A.1"**

ALL AND SINGULAR that certain parcel or strip of land situate lying and being in the Township of North York in the County of York and the Province of Ontario and being composed of part of Block "A" according to a plan filed in the Registry Office for the Registry Division of the East and West Ridings of the County of York as No. 3456 York, and part of Lots twelve (12), thirteen (13) and fourteen (14), Concession One (1), East of Yonge Street, of the original Township of York. The said strip of land having a perpendicular width of fifty feet (50.0') and lying twenty-five feet (25.0') on either side of a centre line and production of same, which said centre line is more particularly described as follows:

PREMISING that the easterly limit of Registered Plan No. 3517 York has a course of North seven degrees thirty-seven minutes and forty seconds West (N 7° 37' 40" W) and relating all courses herein thereto;

COMMENCING at a point in the southerly limit of said Block "A", Registered Plan No. 3456 York distant eighty-five and fifty-four hundredths feet (85.54') measured westerly thereon, from the south-easterly angle of the said Block "A";

THENCE North thirty-two degrees fifteen minutes and ten seconds West (N 32° 15' 10" W) four hundred and thirty-six and seven hundredths feet (436.07');

THENCE North eighty-five degrees and forty-two minutes West (N 85° 42' W) five hundred and ninety-three and eighty-three hundredths feet (593.83');

THENCE North sixty-six degrees and fifty-one minutes West (N 66° 51' W) seven hundred and eighty-six and nineteen hundredths feet (786.19');

THENCE North twenty degrees fifty-eight minutes ten seconds West (N 20° 58' 10" W) one hundred and ninety-six and nine hundredths feet (196.09');

THENCE North twenty-four degrees forty-three minutes and twenty seconds East (N 24° 43' 20" E) thirteen hundred and ninety and forty-two hundredths feet (1390.42');

THENCE North fourteen degrees ten minutes West (N 14° 10' W) four hundred and eighty-nine and sixty-two hundredths feet (489.62');

THENCE North forty-eight degrees one minute and twenty seconds West (N 48° 01' 20" W) twelve hundred and thirty-three and forty-one hundredths feet (1233.41'), more or less, to a point in the southerly limit of Highway No. 401 as described in Instrument No. 109982 York, said point being located as follows:

BEGINNING at the north-easterly angle of Registered Plan No. 3563 York;

THENCE North fifty-eight degrees twenty-four minutes forty seconds East (N 58° 24' 40" E) four hundred and twelve and forty-seven hundredths feet (412.47') in the said southerly limit of Highway No. 401;

THENCE North sixty-four degrees twenty-two minutes East (N 64° 22' E) three hundred and thirteen and ten hundredths feet (313.10') in the said southerly limit of Highway No. 401 to the said point.

SAVE AND EXCEPT that certain parcel of land, lying and being within the plan of subdivision registered as Plan 66M-2331.
