PREFACE AND EXPLANATORY NOTES

TO AMENDMENT NO. 509

TO THE OFFICIAL PLAN OF THE

CITY OF NORTH YORK

LANDS AFFECTED BY THIS AMENDMENT

This amendment concerns the lands located at the north-east corner of Don Mills Road and Eglinton Avenue East. The municipal address is 825 Don Mills Road.

EFFECT OF AMENDMENT

The effect of this amendment would be to permit a stand alone retail store and ancillary retail and service commercial uses.

PUBLIC MEETINGS

The Midtown Community Council considered Amendment Application UDOZ-00-018 at a statutory public meeting held on September 12, 2001, after written notice of such meeting had been sent to all persons assessed in respect of land and to all tenants within 120 metres of the subject lands. It was Midtown Community Council's decision to recommend approval of the application.

A meeting to consider this matter was held by Council of the City of Toronto on October 2, 3 and 4, 2001. Council adopted the recommendation of the Midtown Community Council to approve the application.

On February 15, 2002, Council enacted By-law No. 16-2002.

The following text constitutes Amendment No. 509 to the Official Plan of the City of North York.

ITEM 1

Clause 1

Part D.13 (Business Parks Secondary Plan) of the Official Plan, Section 3.1.2 is amended as follows:

The text of Section 3.1.2 is deleted and replaced with the following:

"Notwithstanding the permitted uses and gross floor area limitations in subsection 3.1.0(q), the lands known as 825 Don Mills Road may be used for a stand alone retail store and ancillary retail and service commercial uses".
