BY-LAW No. 26-2002

To amend By-law No. 2958-94 of the former City of York, being a By-law “To regulate traffic on City of York Roads”.

The Council of the City of Toronto HEREBY ENACTS as follows:

NO PARKING - SCHEDULE VIII

1. That Schedule VIII of former City of York By-law No. 2958-94, as amended, be further amended by deleting in Columns 1, 2, 3, and 4 of said Schedule the following:

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>Side</u>	<u>Column 3</u> <u>Between</u>	<u>Column 4</u> <u>Prohibited</u> <u>Times or Days</u>
Valport Court	North and South	The westerly terminus street and Esposito Crescent	Anytime

NO PARKING – SCHEDULE VIII

2. That Schedule VIII of former City of York By-law No. 2958-94, as amended, be further amended by inserting in Columns 1, 2, 3 and 4 of said Schedule the following:

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>Side</u>	<u>Column 3</u> <u>Between</u>	<u>Column 4</u> <u>Prohibited</u> <u>Times or Days</u>
Robina Avenue	East	A point 20.5 metres south of Glenhurst Avenue and a point 8.0 metres south thereof	Anytime
Silverthorn Avenue	East	A point 64 metres north of Rogers Road and a point 5.5 metres north thereof	Anytime
