**CITY OF TORONTO**

**BY-LAW No. 96-2002**

**To amend further Metropolitan By-law No. 32-92, respecting the regulation of traffic on former Metropolitan Roads.**

The Council of the City of Toronto HEREBY ENACTS as follows:

- Schedule VI (Prohibited Pedestrian Crossings) of Metropolitan By-law No. 32-92, as amended, is further amended by inserting the following words and figures in Columns 1 and 2 of the said Schedule:

(In Column 1)	(In Column 2)
Sheppard Avenue East (M.T. 28)	Between the west curb line of Doris Avenue and a point 30.5 metres east of the east curb line of Doris Avenue
Yonge Street (M.T. 29)	Between the north curb line of Poyntz Avenue and a point 30.5 metres south of the south curb line of Poyntz Avenue

- Schedule XIII (One-Way Traffic Lanes) of Metropolitan By-law No. 32-92, as amended, is further amended by striking out the words and figures:

Sheppard Avenue West and Beecroft Road (M.T. 28)	Beecroft Road and a point 30.5 metres west thereof	Southerly Eastbound	Anytime	Eastbound right-turning (buses excepted)
