BY-LAW No. 100-2002

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,
respecting Earls court Avenue, Indian Grove, Marion Street, Pauline Avenue,
Pelham Avenue, St. Clarens Avenue, Silverthorn Avenue, Symington Avenue,
Westmoreland Avenue.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Schedule XXXVIII (Designated On-Street Parking for Disabled Person Parking Permit Holders) in § 400-91, the following in alphabetical order by street name:

Marion Street	South	A point 63.5 metres west of Fuller Avenue and a point 5.5 metres further west thereof	Anytime
Pauline Avenue	East	A point 99 metres south of Wallace Avenue and a point 5.5 metres further south	Anytime
St. Clarens Avenue	East	A point 63 metres north of Wallace Avenue and a point 5.5 metres further north thereof	Anytime
Westmoreland Avenue	East	A point 23 metres north of Fernbank Avenue and a point 5.5 metres further north thereof	Anytime

B. By inserting in Schedule XXXVIII (Designated On-Street Parking for Disabled Person Parking Permit Holders) in § 400-91, the following in alphabetical order by street name:

Earls court Avenue	East	A point 34.5 metres south of Ascot Avenue and a point 5.5 metres further south	Anytime
Indian Grove	West	A point 120.0 metres north of Bloor Street West and a point 5.5 metres further north	Anytime

Silverthorn Avenue	East	A point 64 metres north of Rogers Road and a point 5.5 metres further north	Anytime
Symington Avenue	West	A point 58 metres north of Antler Street and a point 5.5 metres further north	Anytime
