**CITY OF TORONTO**

**BY-LAW No. 102-2002**

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Cannes Circle, Mondovi Gate, Tarragona Boulevard, Symes Road, Viella Street.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By inserting in Schedule I (One-Way Highways) in § 400-54, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)
Cannes Circle	Entire Length	Anytime	South-east to north-east

B. By inserting in Schedule III (Through Highways) in § 400-56, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)
Symes Road	St. Clair Avenue West and the south limit of Glen Scarlett Road

C. By inserting in Schedule IV (Stop Intersections) in § 400-57, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)
Mondovi Gate and Tarragona Boulevard	Mondovi Gate
Tarragona Boulevard and Gunns Road	Tarragona Boulevard (eastbound)
Tarragona Boulevard and Mondovi Gate	Tarragona Boulevard (eastbound and westbound)
Viella Street (north/south leg) and Tarragona Boulevard	Viella Street (southbound)

D. By inserting in Schedule XVI (Speed Limits on Highways) in § 400-69, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)
Cannes Circle	40	Entire Length
Mondovi Gate	40	St. Clair Avenue West and Tarragona Boulevard
Viella Street	40	Symes Road and Tarragona Boulevard

E. By inserting in Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)
Cannes Circle	North, east and south	Entire Length	Anytime
Symes Road	West	St. Clair Avenue West and Glen Scarlett Road	Anytime
Tarragona Boulevard	North	Symes Road and Viella Street	Anytime
Tarragona Boulevard	South	A point 19 metres west of Viella Street and Gunns Road	Anytime
Viella Street	South and West	Symes Road and Tarragona Boulevard	Anytime
