**CITY OF TORONTO**

**BY-LAW No. 109-2002**

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Ardagh Street, Armadale Avenue, Beresford Avenue, Durie Street, Evans Avenue, Grassmere Road, Lansdowne Avenue, Lincoln Avenue, MacGregor Avenue, Nelles Avenue, Roncesvalles Avenue, Wade Avenue, Wallace Avenue, Weatherell Street, Willard Avenue.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By inserting in Schedule IV (Stop Intersections) in § 400-57, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)
Ardagh Street and Armadale Avenue	Ardagh Street (eastbound and westbound)
Ardagh Street and Willard Avenue	Ardagh Street (eastbound and westbound)
Wade Avenue and Paton Road	Wade Avenue (northbound)

B. By inserting in Schedule XII (Pedestrian Cross-Overs) in § 400-65, the following in alphabetical order by street name:

Roncesvalles Avenue	Immediately north of Grenadier Road (south junction)

C. By inserting in Schedule XVI (Speed Limits on Highways) in § 400-69, the following in alphabetical order by street name:

D. By inserting in Schedule XXIV (No Stopping) in § 400-77, the following in alphabetical order by street name:

E. By deleting from Schedule XXXIX (Designated On-Street Loading Zones for Disabled Person Parking Permit Holders) in § 400-92, the following in alphabetical order by street name:

Wallace Avenue	South	A point 51 metres west of Lansdowne Avenue	A point 5.5 metres further west thereof	6:00 a.m. to 6:30 a.m. and 12:00 noon to 1:00 p.m., Mon. to Fri.

F. By inserting in Schedule XXXIX (Designated On-Street Loading Zones for Disabled Person Parking Permit Holders) in § 400-92, the following in alphabetical order by street name:

Wallace Avenue	South	A point 51 metres west of Lansdowne Avenue	A point 5.5 metres further west	6:00 a.m. to 1:00 p.m., Mon. to Fri.
