BY-LAW No. 234-2002

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,
respecting Carlaw Avenue and Wheeler Avenue.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

(From Column 1)	(From Column 2)	(From Column 3)	(From Column 4)
Carlaw Avenue	West	A point 123.8 metres south of Eastern Avenue and a point 30.4 metres further south	7:00 a.m. to 6:00 p.m. except Sat., Sun. and Public Holidays

B. By inserting in Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)
Wheeler Avenue	East	A point 216.0 metres south of Norway Avenue and a point 228.5 metres south of Norway Avenue	Anytime

C. By deleting from Schedule XXV (Time Limit Parking) in § 400-78, the following in alphabetical order by street name:

Wheeler Avenue	East	Queen Street East and a point 63.7 metres south of Norway Avenue	Anytime	2 hours

D. By inserting in Schedule XXV (Time Limit Parking) in § 400-78, the following in alphabetical order by street name:

Wheeler Avenue	East	A point 216.0 metres south of Norway Avenue and a point 63.7 metres south of Norway Avenue	Anytime	2 hours

E. By inserting in Schedule XXIX (No Standing)) in § 400-82, the following in alphabetical order by street name:

Carlaw Avenue	West	A point 123.8 metres south of Eastern Avenue and a point 30.4 metres further south	7:00 a.m. to 6:00 p.m., Mon. to Fri.
