BY-LAW No. 251-2002

To stop up and close part of the public highway Viking Road and to authorize the sale thereof.

WHEREAS it is recommended that part of the public highway Viking Road be stopped up and closed as a public highway and be sold on the terms and conditions set out in Clause No. 240 of Administration Committee Report No. 16, as adopted by the former City of Etobicoke Council at its meeting held on September 22, 1997, Clause No. 11 of Etobicoke Community Council Report No. 14, as adopted by City Council at its meeting held on December 14, 15 and 16, 1999 and Notice of Motion J(7), moved by Councillor Milczyn and seconded by Councillor Holyday, as adopted by City Council at its meeting held on June 26, 27 and 28, 2001; and

WHEREAS notice of the proposed by-law to stop up and close the said portion of highway and to authorize the sale thereof was published in the Toronto Star on February 4, 11, 18 and 25, 2002 and in the Etobicoke Guardian on February 20, 2002 and no one who claimed that the person's land would be prejudicially affected by the said by-law applied to be heard;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. The portion of the public highway Viking Road, described as follows:

Part of PIN 07549-0107 (LT)

Part of the Public Highway Viking Road, formerly Woodlawn Avenue, on Plan 2706, designated as Part 1 on Plan 66R-19458 in the Land Titles Division of the Toronto Registry Office (No. 66) in the City of Toronto (formerly the City of Etobicoke) and Province of Ontario is hereby stopped up and closed as a public highway.

2. The soil and freehold of the public highway stopped up and closed by Section 1 of this By-law shall be sold on the terms and conditions set out in Clause No. 240 of Administration Committee Report No. 16, as adopted by the former City of Etobicoke Council at its meeting held on September 22, 1997, Clause No. 11 of Etobicoke Community Council Report No. 14, as adopted by City Council at its meeting held on December 14, 15 and 16, 1999 and Notice of Motion J(7), moved by Councillor Milczyn and seconded by Councillor Holyday, as adopted by City Council at its meeting held on June 26, 27 and 28, 2001.
