BY-LAW No. 363-2002

To amend further Metropolitan By-law No. 32-92, respecting the regulation of traffic on former Metropolitan Roads.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Schedule XIII (One-Way Traffic Lanes) of Metropolitan By-law No. 32-92, as amended, is further amended by inserting the following words and figures in Columns 1, 2, 3, 4 and 5 of the said Schedule:

Islington Avenue and Steeles Avenue West (M.T. 63)	Steeles Avenue West and a point 70 metres south thereof	Easterly Northbound	Anytime	Northbound right-turning (buses excepted)
Jane Street and Firgrove Crescent (south leg) (M.T. 5)	Firgrove Crescent (south leg) and a point 20 metres north thereof	Westerly Southbound	Anytime	Southbound right-turning (buses excepted)
Jane Street and Rita Drive (M.T. 5)	Rita Drive and a point 20 metres south thereof	Easterly Northbound	Anytime	Northbound right-turning (buses excepted)
Jane Street and Yewtree Boulevard (M.T. 5)	Yewtree Boulevard and a point 20 metres south thereof	Easterly Northbound	Anytime	Northbound right-turning (buses excepted)

2. Schedule XV (Prohibited Turns) of Metropolitan By-law No. 32-92, as amended, is further amended by striking out the words and figures:

Steeles Avenue West and Easton Road (M.T. 28)	Eastbound	Right	7:00 a.m. to 9:00 a.m. Monday to Friday except Public Holidays (buses excepted)

where they occur opposite each other in Columns 1, 2, 3 and 4 of the said Schedule and inserting in lieu thereof the following:
