CITY OF TORONTO

BY-LAW No. 385-2002

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Bedford Park Avenue, Belsize Drive, Chaplin Crescent, Cheston Road, and Frobisher Avenue.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:
