**CITY OF TORONTO**

**BY-LAW No. 433-2002**

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,  
 respecting Manning Avenue.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Part P (12:01 a.m. to 10:00 a.m.) in Schedule XXVI (Permit Parking) in § 400-79 the following in alphabetical order by street name:

Manning Avenue	Even	From Harbord Street to Bloor Street West	51	All times, except no parking from 8:30 a.m. to 6:00 p.m. from a point 45 metres south of Bloor Street West to Bloor Street West

B. By inserting in Part P (12:01 a.m. to 10:00 a.m.) of Schedule XXVI (Permit Parking) in § 400-79, the following in alphabetical order by street name:

C. By inserting in Part AD (12:01 a.m. to 7:00 a.m., Mon. to Fri. and 12:01 a.m. to 8:00 a.m., Sat. and Sun.) of Schedule XXVI (Permit Parking) in § 400-79, the following in alphabetical order by street name:

Manning Avenue	Even	From a point 32 metres north of Harbord Street to a point 14 metres further north	2	All times

D. By inserting in Schedule XXXIX (Designated On-Street Loading Zones for Disabled Person Parking Permit Holders) in § 400-92, the following in alphabetical order by street name:
