CITY OF TORONTO

BY-LAW No. 437-2002

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,
respecting Brunswick Avenue, Major Street, Ulster Street.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Schedule I (One-Way Highways) in § 400-54, the following in alphabetical order by street name:

| (From Column 1) | (From Column 2) | (From Column 3) | (From Column 4) |
|---------------------|---|--------------------|---------------------|
| Brunswick Avenue | Ulster Street and a point 170 metres south thereof | Anytime | From north to south |

B. By inserting in Schedule I (One-Way Highways) in § 400-54, the following in alphabetical order by street name:

| (In Column 1) | (In Column 2) | (In Column 3) | (In Column 4) |
|---------------------|---|------------------|---------------------|
| Brunswick Avenue | Ulster Street and a point 210 metres south | Anytime | From north to south |

C. By deleting from Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

| (From Column 1) | (From Column 2) | (From Column 3) | (From Column 4) |
|---------------------|--------------------|--|--------------------|
| Brunswick Avenue | West | A point 36.4 metres north of College Street and a point 163.2 metres north of it | Anytime |

D. By inserting in Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

| (In Column 1) | (In Column 2) | (In Column 3) | (In Column 4) |
|------------------|---------------|--|---------------|
| Brunswick Avenue | West | A point 36.4 metres north of College Street and a point 123.2 metres further north | Anytime |

E. By deleting from Schedule XXV (Time Limit Parking) in § 400-78, the following in alphabetical order by street name:

|------------------|-----------------|--|------------------------|-----------------|
| Brunswick Avenue | West | A point 199.6 metres north of College Street and Ulster Street | 8:00 a.m. to 6:00 p.m. | 60 mins. |
| Major Street | East | College Street and Harbord Street | 8:00 a.m. to 6:00 p.m. | 60 mins. |

F. By inserting in Schedule XXV (Time Limit Parking) in § 400-78, the following in alphabetical order by street name:

| Major Street | East | College Street and Ulster Street | 10:00 a.m. to 7:00 p.m. | 1 hour |
| Major Street | East | Ulster Street and Harbord Street | 8:00 a.m. to 6:00 p.m. | 1 hour |
| Ulster Street | South | Brunswick Avenue and Major Street | 10:00 a.m. to 7:00 p.m. | 1 hour |

G. By deleting from Part D (12:00 midnight to 7:00 a.m.) in Schedule XXVI (Permit Parking) in § 400-79, the following in alphabetical order by street name:

| Brunswick Avenue | Even | From a point 200 metres north of College Street to a point 38 metres south of Ulster Street | 21 | All times |
| Major Street | Odd | From College Street to Harbord Street | 83 | All times |
| Ulster Street | Even | From Major Street to Bathurst Street | 45 | All times, except no parking anytime from a point 25 metres east of Borden Street a point 5.5 metres further east of it |
| Ulster Street | Even | From Major Street to Bathurst Street | 46 | All times |

H. By inserting in Part D (12:00 midnight to 7:00 a.m.) in Schedule XXVI (Permit Parking) in § 400-79, the following in alphabetical order by street name:

|---------------|---------------|--|---------------|--|
| Major Street | Odd | From Ulster Street to Harbord Street | 29 | All times |
| Ulster Street | Even | From Bathurst Street to Brunswick Avenue | 31 | All times, except no parking anytime from a point 25 metres east of Borden Street to a point 5.5 metres further east |

I. By inserting in Part P (12:01 a.m. to 10:00 a.m.) in Schedule XXVI (Permit Parking) in § 400-79, the following in alphabetical order by street name:

| (In Column 1) | (In Column 2) | (In Column 3) | (In Column 4) | (In Column 5) |
|------------------|---------------|---|---------------|---------------|
| Brunswick Avenue | Even | From a point 200 metres north of College Street to a point 38 metres south of Ulster Street | 24 | All times |
| Major Street | Odd | From College Street to Ulster Street | 63 | All times |
| Ulster Street | Even | From Brunswick Avenue to Major Street | 12 | All times |
