## CITY OF TORONTO

### BY-LAW No. 453-2002

#### To amend further Metropolitan By-law No. 32-92, respecting the regulation of traffic on former Metropolitan Roads.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Schedule VIII (No Parking) of Metropolitan By-law No. 32-92, as amended, is further amended by striking out the following words and figures:

Kingston Road (M.T. 4)	North	A point 43.5 metres east of Glen Manor Drive and a point 34.5 Metres further east thereof	7:00 a.m. to 6:00 p.m. except Saturdays, Sundays and Public Holidays

2. Schedule IX (No Stopping) of Metropolitan By-law No. 32-92, as amended, is further amended by striking out the words and figures:

Kingston Road (M.T. 4)	North and West	Queen Street and a point 43.5 metres east of Glen Manor Drive	7:00 a.m. to 9:00 a.m. except Saturdays, Sundays and Public Holidays
Kingston Road (M.T. 4)	North and West	A point 78 metres east of Glen Manor Drive and Birchmount Road	7:00 a.m. to 9:00 a.m. except Saturdays, Sundays and Public Holidays

where they occur opposite each other in Columns 1, 2, 3 and 4 of the said Schedule and inserting in lieu thereof the following:

3. Schedule XI (No Standing) of Metropolitan By-law No. 32-92, as amended, is further amended by inserting the following words and figures in Columns 1, 2, 3 and 4 of the said Schedule:

Kingston Road (M.T. 4)	North	A point 31.0 metres east of the east curb of Glen Manor Drive and a point 56.0 metres further east thereof	7:00 a.m. to 6:00 p.m. Monday to Friday
