CITY OF TORONTO

BY-LAW No. 511-2002

To amend further Metropolitan By-law No. 32-92, respecting the regulation of traffic on former Metropolitan Roads.

The Council of the City of Toronto HEREBY ENACTS as follows:

- Schedule VIII (No Parking) of Metropolitan By-law No. 32-92, as amended, is further amended by striking out the words and figures:

Avenue Road (M.T. 25)	Both	Lonsdale Road and a point 38.0 metres south of St. Clair Avenue	Anytime
Avenue Road (M.T. 25)	Both	A point 15 metres north of Roxborough Street West and Farnham Avenue	Anytime
Avenue Road (M.T. 25)	Both	A point 38.0 metres south of St. Clair Avenue and Farnham Avenue	Anytime except Sundays

where they occur opposite each other in Columns 1, 2, 3 and 4 of the said Schedule and inserting in lieu thereof the following:
