BY-LAW No. 517-2002

To amend City of Toronto Municipal Code Chapter 19, "Business Improvement Areas", to make changes to the size and quorum of various Business Improvement Area Boards of Management.

WHEREAS Chapter 19 "Business Improvement Areas" of the City of Toronto Municipal Code designates various areas of the City as Business Improvement Areas; and

WHEREAS by the adoption of Clause No.15 of Report No. 6 of the Economic Development and Parks Committee on June 18, 19 and 20, 2002, City of Toronto Council approved the appointment of members to various Business Improvement Area Boards of Management for a term expiring on November 30, 2003, or as soon thereafter as successors are appointed; and

WHEREAS the number of members and the number required for quorum of the Mount Dennis Business Improvement Area and the Upper Village (York) Business Improvement Area are incorrectly identified in Toronto Municipal Code Chapter 19, Business Improvement Areas;

WHEREAS two Councillors have been appointed to the Yonge Lawrence Business Improvement Area Board of Management;

WHEREAS Schedule A of the Toronto Municipal Code, Chapter 19, "Business Improvement Areas" must be amended to reflect the changes in the number of members and the number of members required for quorum of various Business Improvement Area Boards of Management;

The Council of the City of Toronto HEREBY ENACTS as follows:

- **1.** The table in Schedule A of the Toronto Municipal Code, Chapter 19, "Business Improvement Areas", is hereby amended as follows:
 - (1) by changing the number of members of the Greektown on the Danforth Business Improvement Area from 16 to 17 members;
 - (2) by changing the number of members of the Roncesvalles Village Business Improvement Area from 9 to 10;
 - (3) by changing the number of members of the Village of Islington Business Improvement Area from 8 to 7;
 - (4) by changing the number of members of the Liberty Village Business Improvement Area from 16 to 17 and the number of members required for quorum from 7 to 9;

- (5) by changing the number of members of the Mount Dennis Business Improvement Area from 3 to 5 and the number of members required for quorum from 2 to 3;
- (6) by changing the number of members of the Upper Village (York) Business Improvement Area from 4 to 7 and the number of members required for quorum from 3 to 4; and
- (7) by changing the number of members of the Yonge Lawrence Village Business Improvement Area from 8 to 10.
