PREFACE AND EXPLANATORY NOTES

TO AMENDMENT NO. 500

TO THE OFFICIAL PLAN OF THE

CITY OF NORTH YORK

LANDS AFFECTED BY THIS AMENDMENT

This amendment concerns the lands located at the south-west corner of Bayview Avenue and Fifeshire Road. The municipal address is 2722 Bayview Avenue.

EFFECT OF AMENDMENT

The effect of this amendment would be to permit a medical office as an additional use, and to permit a dispensing pharmacy as a temporary use in conjunction with a medical office.

PUBLIC MEETINGS

The Midtown Community Council considered Amendment Application UDZ-00-15 at a statutory public meeting held on June 12, 2001, after written notice of such meeting had been sent to all persons assessed in respect of land and to all tenants within 120 metres of the subject lands. It was Midtown Community Council's decision to recommend approval of the application with amendments.

A meeting to consider this matter was held by Council of the City of Toronto on June 26, 27 and 28, 2001. Council adopted the recommendation of the Midtown Community Council to approve the application with amendments.

On June 20, 2002, Council enacted By-law No. 522-2002.

AMENDMENT NO. 500

TO THE OFFICIAL PLAN OF THE

CITY OF NORTH YORK

The following text and map constitute Amendment No. 500 to the Official Plan of the City of North York.

ITEM 1

Clause 1

Part C.9 – Specific Development – of the Official Plan is amended by adding the following:

"9.227 LANDS ON THE SOUTH-WEST CORNER OF BAYVIEW AVENUE AND FIFESHIRE ROAD (known municipally as 2722 Bayview Avenue)

Notwithstanding the Residential Density One (RD1) designation of the lands shown on Map C.9.227, the lands may be used for a medical office. In addition, the lands may be used for a dispensing pharmacy only in conjunction with the medical office, in accordance with a temporary use by-law enacted for the site."

Clause 2

Part C.9 – Specific Development – of the Official Plan is amended by adding Map C.9.227 attached hereto.
