BY-LAW No. 534-2002

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,
re: various streets in connection with World Youth Day events.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:
 - A. By inserting in Schedule XXIX (No Standing) in § 400-82, the following in alphabetical order by street name:

B. This by-law shall come into force commencing July 23, 2002 at 7:00 a.m. and shall automatically expire on July 27, 2002 at 7:01 a.m. and thereafter be of no force and effect.

C. To the extent that there is a conflict between this by-law and any of § 400-33 E, F, G, H, § 400-35 and § 400-37 of the former City of Toronto Municipal Code, this by-law shall prevail.
