CITY OF TORONTO

BY-LAW No. 539-2002

To amend former City of Toronto Municipal Code Chapter 400, Traffic and Parking, to accommodate World Youth Day 2002 Events.

WHEREAS in order to provide for permit parking between 9:00 p.m. and 10:00 a.m. Monday July 22, 2002 to Sunday July 28, 2002, it is necessary to create a new Part AI of Schedule XXVI (Permit Parking) of the former City of Toronto Municipal Code Ch. 400, Traffic and Parking;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:
 - A. By deleting from §§ 400-38B and 400-38D(1): “AE, AG, or AH” and replacing it with: “AE, AG, AH, or AI”.
 - B. By inserting in § 400-38E the following:

“Part AI 9:00 p.m. to 10:00 a.m. Monday July 22, 2002 to Sunday, July 28, 2002”
 - C. By deleting from § 400-38G(2)(a): “AE, AG, or AH” and replacing it with: “AE, AG, AH, or AI”.
 - D. By inserting in Schedule XXVI (Permit Parking) of § 400-79 the following:

(51) Part AI 9:00 p.m. to 10:00 a.m Monday July 22, 2002 to Sunday July 28, 2002
 - E. By inserting in Part AI in Schedule XXVI (Permit Parking) of § 400-79 the following in alphabetical order by street name:
