## BY-LAW No. 563-2002

## To layout and dedicate certain land between Bathurst Street and Lake Shore Boulevard for public highway purposes to form part of the public highway Fort York Boulevard.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Certain land to form part of the public highway Fort York Boulevard, described by W. Kowalenko, O.L.S., City Surveyor, as follows, namely:

In the City of Toronto and Province of Ontario, in the Land Registry Office for the Registry Division of the Toronto Registry Office (No. 66) being composed of:

Being part of Parcel 1 on Plan 1101 and part of the Water Lot Fronting the Ordnance Reserve designated as PARTS 77, 78 and 80 on Plan 64R-14891, lying below a plane having an elevation of 89.46 metres, Canadian Geodetic Datum.

Being part of Parcel 1 on Plan 1101 and part of the Water Lot Fronting the Ordnance Reserve designated as PARTS 39, 79, 93 and 94 on Plan 64R-14891 and PARTS 2, 3, 4 and 5 on Plan 64R-17072.

Being part of Parcel 1 on Plan 1101, part of Block E on Plan D-1444 and part of the Water Lot Fronting the Ordnance Reserve designated as PART 6 on Plan 64R-17072.

Part of the Water Lot Fronting the Ordnance Reserve designated as PART 1 on Plan 66R-19717 is laid out and dedicated for public highway purposes to form part of Fort York Boulevard.

**2.** Certain land to form part of the public highway Fort York Boulevard, described by W. Kowalenko, O.L.S., City Surveyor, as follows, namely:

In the City of Toronto and Province of Ontario, in the Land Registry Office for the Registry Division of the Toronto Registry Office (No. 66) being composed of:

Being part of Block 14 on the Plan of the Ordnance Reserve designated as PART 7 on Plan 64R-17072 and PART 1 on Plan 66R-19688 is laid out and dedicated for public highway purposes to form part of Fort York Boulevard.

- **3.** Section 2 of this By-law does not come into effect until the lease of the lands described in Section 2 has been surrendered by the tenant.
- **4.** Certain land to form part of the public highway Fort York Boulevard, described by W. Kowalenko, O.L.S., City Surveyor, as follows, namely:

In the City of Toronto and Province of Ontario, in the Land Registry Office for the Registry Division of the Toronto Registry Office (No. 66) being composed of:

Being part of Block E on Plan D-1444 and part of the Water Lot Fronting the Ordnance Reserve designated as PART 8 on Plan 64R-17072 is laid out and dedicated for public highway purposes to form part of Fort York Boulevard.

5. Section 4 of this By-law does not come into effect until the conveyances to the City of the lands described in Section 4 and the necessary land registrations respecting those conveyances are completed.
