CITY OF TORONTO

BY-LAW No. 602-2002

To levy an amount for the year 2002 upon certain Universities and Colleges.

WHEREAS subsection 157(1) of the *Municipal Act*, as amended (the “Act”), provides among other things that, notwithstanding any general or special Act, the Council of a local municipality may pass by-laws to levy an annual tax upon a university and a college of applied arts and technology designated by the Minister of Colleges and Universities not exceeding the prescribed amount for each full time student enrolled in such university or college in the year preceding the year of the levy as determined by the Minister of Colleges and Universities; and

WHEREAS pursuant to O.Reg 129/02, the sum of \$75 is prescribed for 2002, for the purposes of subsection 157(1) of the Act; and

WHEREAS the Minister of Colleges and Universities has designated the following institutions as universities and colleges of applied arts and technology for the purposes of subsection 157(1) of the Act and has determined the following to be the applicable full-time enrolment:

The Council of the City of Toronto HEREBY ENACTS as follows:

1. The sum of \$75 is fixed as the amount levied in 2002 for each full time university and college student and there shall be levied for the year 2002 upon the following universities and colleges of applied arts and technology the amounts shown as follows, payable on the 20th day of September, 2002, for a total levy of \$8,947,350.00:
