CITY OF TORONTO

BY-LAW No. 603-2002

To levy an amount for the year 2002 upon certain Correctional Facilities.

WHEREAS subsection 157(3) of the *Municipal Act*, as amended (the "Act"), provides among other things that, notwithstanding any general or special Act, the Council of a local municipality may pass by-laws to levy an annual tax upon a correctional institution or training school or place of secure custody designated under the *Young Offenders Act (Canada)* designated by the Minister of Correctional Services not exceeding the prescribed amount for each resident place in the institution or school as determined by the Minister of Correctional Services; and

WHEREAS pursuant to O.Reg 129/02, the sum of \$75 is prescribed for 2002, for the purposes of subsection 157(3) of the Act; and

WHEREAS the Minister of Correctional Services has designated the following institutions as correctional institutions or training schools or place of secure custody designated under the *Young Offenders Act (Canada)* for the purposes of subsection 157(3) of the Act and has determined the following to be resident places:

| Institution | Resident Places |
|---------------------------------|-----------------|
| Mimico Correctional Centre | 404 |
| Toronto East Detention Centre | 408 |
| Toronto Jail | 504 |
| Toronto West Detention Centre | 604 |
| Toronto Youth Assessment Centre | 136 |

Therefore the Council of the City of Toronto HEREBY ENACTS as follows:

1. The sum of \$75 is fixed as the amount levied for each resident place, and there shall be levied for the year 2002 upon the following correctional institutions, training schools, and places of secure custody designated under the *Young Offenders Act (Canada)*, the total amounts shown as follows, payable on the 20th day of September, 2002, for a total levy of \$154,200.00:

| Institution | 2002 Amount |
|---------------------------------|-------------|
| Mimico Correctional Centre | \$ 30,300 |
| Toronto East Detention Centre | \$ 30,600 |
| Toronto Jail | \$ 37,800 |
| Toronto West Detention Centre | \$ 45,300 |
| Toronto Youth Assessment Centre | \$ 10,200 |

2. Sections 1, 3, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22 and 23 respectively of By-law No. 187-2002 apply to the taxes levied by section 1 hereof.
