## CITY OF TORONTO

### BY-LAW No. 633-2002

**To amend current City of Toronto By-laws No. 30742 (North York), No. 197 (East York), No. 107-86 (Metro), No. 1645-89 (York), No. 22614 (Scarborough), and Municipal Code Chapters 187 (Etobicoke), 400 (Toronto), and 982 (York) respecting the use of parking meters, and The City of Toronto Municipal Code Chapter 910 respecting the use of parking machines, to establish new voluntary payment amounts and set fine amounts with respect to offences.**

WHEREAS City Council has directed that the amount of the voluntary payments for penalties under by-laws of the City of Toronto respecting the use of parking meters and parking machines be set at \$20.00 (payment within 7 days of the date of the ticket) and that the City Solicitor apply to the Province to establish the set fine for offences under these by-laws at \$30.00; and

WHEREAS it is therefore necessary to amend the by-laws of the former Area Municipalities and that of the new City of Toronto to reflect these new uniform voluntary payment amounts;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. By-law No. 30742, being “A By-law Respecting Parking Meters on the City of North York Roads” of the former City of North York, is amended by deleting from Subsection 10(3) the amount of “\$15.00” and substituting therefor the amount of “\$20.00”.
2. By-law No. 197, being “A By-law To Provide for Parking Meters on Roads in the Borough of East York”, of the former Borough of East York is amended by deleting from Subsection 12(c) the amount of “\$15.00” and substituting therefor the amount of “\$20.00”.
3. By-law No. 107-86, being “A By-law Respecting Parking Meters on Metropolitan Roads”, of the former Municipality of Metropolitan Toronto, is amended by deleting from Subsection 11(3) the amount of “\$15.00” and substituting therefor the amount of “\$20.00”.
4. Chapter 187, Parking Meters, of the Municipal Code of the former City of Etobicoke, is amended by deleting from Subsection 187-9C(3) the amount of “\$15.00” and substituting therefor the amount of “\$20.00”.
5. Chapter 400, Traffic and Parking, of the Municipal Code of the former City of Toronto, is amended by repealing the reference to § 400-42 under Columns 1, 2 and 3 of subsection 400-11B(1), and substituting the following:

- 6.** Chapter 910, Parking Machines, of The City of Toronto Municipal Code is amended by deleting from Subsection 910-10C the amount of “\$15” and substituting therefor the amount of “\$20”.
  - 7.** Chapter 982, Parking – Meter, of the Municipal Code of the former City of York, is amended by deleting from Section 982.3.3 the amount of “\$15.00” and substituting therefor the amount of “\$20.00”.
  - 8.** By-law No. 1645-89, being “A By-law Respecting Parking Meters”, of the former City of York, is amended by deleting from Subsection 11(3) the amount of “\$15.00” and substituting therefor the amount of “\$20.00”.
  - 9.** By-law No. 22614, being “A By-law Respecting Parking Meters on Scarborough Roads”, of the former City of Scarborough, is amended by deleting from subsection 10(c) the amount of “\$15.00” and substituting therefor the amount of “\$20.00”.
  - 10.** In the case of a conflict between the provisions of this by-law and the provisions of any by-law or Municipal Code Chapter amended under sections 1 to 9 herein, the provisions of this by-law shall prevail.
  - 11.** This by-law shall come into force upon the date of approval by the Regional Senior Justice of the set fine application for the by-laws or Municipal Code Chapters amended by this by-law.
