BY-LAW No. 670-2002

To amend By-law No. 13897, a by-law providing for the designation of fire routes in the geographic area of the former City of Scarborough, a by-law of the former City of Scarborough.

WHEREAS, pursuant to the *City of Toronto Act*, 1997, S.O. 1997, c. 2, every by-law or resolution of an old council that is in force immediately before January 1st, 1998 is deemed to be a by-law or resolution of the Council of the City of Toronto and remains in force, in respect of the part of the urban area to which it applied immediately before January 1st, 1998, until the Council repeals it or amends it to provide otherwise; and

WHEREAS By-law No. 13897 of the former City of Scarborough, as amended, provides for the designation of locations in the former Scarborough as fire routes where such locations meet the requirements of that By-law; and

WHEREAS By-law No. 13897 was in force in the former Scarborough immediately before January 1st, 1998 and has not been repealed or amended to provide otherwise by the Council of the City of Toronto; and

WHEREAS the Fire Department is satisfied that locations identified in Schedule "A" of this By-law meet the requirements of By-law No. 13897 for designation of those locations as fire routes; and

WHEREAS the applicants for the designation of those locations as fire routes have signed the related fire route agreements required by the Fire Department for the designation of fire routes in the former Scarborough;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Schedule "B" of By-law No. 13897 of the former City of Scarborough, now a by-law of the City of Toronto, is hereby amended by adding thereto the locations identified in Schedule "A" of this By-law, thereby designating those locations as fire routes within the meaning of the By-law No. 13897.
