## CITY OF TORONTO

## **BY-LAW No. 739-2002**

## To amend City of Toronto Municipal Code Chapter 545, Licensing.

WHEREAS By-law No. 514-2002, "A By-law to adopt a new City of Toronto Municipal Code Chapter 545, Licensing," is a codified version of By-law No. 574-2000, "Respecting the licensing, regulating and governing of trades, businesses and occupations in the City of Toronto, as amended; and

WHEREAS By-law No. 514-2002 also repeals By-law No. 574-2000 and comes into force on October 31, 2002; and

WHEREAS By-law No. 574-2000 has been amended by the following by-laws that were not reflected in Chapter 545:

By-law No. 481-2002, "A By-law to amend further City of Toronto By-law No. 574-2000 regarding trip records used by taxicab drivers"; and

By-law No. 513-2002, "A By-law to amend further City of Toronto By-law No. 574-2000, regarding Watch for Bikes stickers in taxicabs".

The Council of the City of Toronto HEREBY ENACTS as follows:

- **1.** Chapter 545, Licensing, of the City of Toronto Municipal Code is amended by adding the following subsection:
  - § 545-136E(1)(h) three "Watch for Bikes" stickers, in a form approved by the Commissioner or his or her delegate, one affixed to the driver's side mirror, one affixed to the right rear side window and one affixed to the left rear side window, affixed in manner that will not obstruct the driver's view.
- **2.** Chapter 545 is further amended by deleting §§ 545-141B, 545-141C, 545-141D, 545-141E and 545-150N.
- **3.** Subsection 545-141A(1) of Chapter 545 is amended by adding the words "who drives a cab" after the word "owner" and before the word "shall" and deleting the word "daily".
- **4.** Subsection 545-141A(1)(d) of Chapter 545 is amended by deleting the word "date".
- 5. Subsection 545-141A(1)(f) of Chapter 545 is amended by adding the words "date and" after the word "the" and before the word "time".

- **6.** Subsection 545-141A(2) of Chapter 545 is amended by deleting the phrase "prior to the commencement of the next following trip" and inserting the phrase "on the trip sheet as soon as practical after the conclusion of each trip" in lieu thereof.
- **7.** Subsection 545-141A of Chapter 545 is further amended by adding the following subsection:
  - § 545-141A(3) Subsections 545-141A(1)(d) and 545-141A(1)(e) may not apply to a driver or an owner who drives a taxicab where the drivers and owner have voluntarily consented in writing to provide statistical data required by the City of Toronto by allowing the City of Toronto to download data from the taxi meter as directed by the Commissioner or any person authorized by him or her.
- 8. Section 545-141F is amended by deleting the word "owner" and adding the phrase "driver or owner who drives a taxicab" in lieu thereof.
- 9. This By-law comes into force on October 31, 2002.
