CITY OF TORONTO

BY-LAW No. 740-2002

To amend City of Toronto Municipal Code Chapter 849, Water and Sewage Services, respecting water rates.

WHEREAS as part of the City of Toronto's water rate harmonization program it is necessary and appropriate for the City of Toronto to set water and sewer rates;

The Council of the City of Toronto HEREBY ENACTS as follows:
