**CITY OF TORONTO**

**BY-LAW No. 749-2002**

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,  
respecting Bay Street and Dundas Square.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By inserting in Schedule VIII (Prohibited Turns) in § 400-61, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)
Bay Street, between Bloor Street West and Yorkville Avenue	Northbound and Southbound	U-turns	Anytime

B. By deleting from Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

Dundas Square	North	Entire length	Anytime

C. By inserting in Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

Dundas Square	Both	Entire length	Anytime

D. By deleting from Schedule XXV (Time Limit Parking) in § 400-78, the following in alphabetical order by street name:

Dundas Square	South	Yonge Street and Victoria Street	8:00 a.m. to 6:00 p.m., Mon. to Sat.	60 mins.
