**CITY OF TORONTO**

**BY-LAW No. 750-2002**

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,  
respecting Banff Road, Gange Avenue, Hillhurst Boulevard, Nina Street, Old Park Road,  
and Oriole Road.**

The Council of the City of Toronto HEREBY ENACTS as follows:
