**CITY OF TORONTO**

**BY-LAW No. 812-2002**

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,  
respecting McRoberts Avenue.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

McRoberts Avenue	East	Entire length	Anytime

B. By inserting in Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

McRoberts Avenue	East	A point 43 metres north of St. Clair Avenue West and a point 83 metres south of Rogers Road	Anytime

C. By inserting in Schedule XXIX (No Standing) in § 400-82, the following in alphabetical order by street name:

McRoberts Avenue	Both	St. Clair Avenue West and a point 43 metres north	Anytime

D. By deleting from Part A (12:01 a.m. to 7:00 a.m.) in Schedule XXVI (No Standing) in § 400-79, the following in alphabetical order by street name:

McRoberts Avenue	Even	From St. Clair Avenue West to the north City limit	62	All times, except no parking 8:30 a.m. to 5:30 p.m., Mon. to Fri., from Innes Avenue to a point 106.7 metres south; no parking anytime from a point 138 metres north of St. Clair Avenue West to a point 5 metres further north; no parking anytime from 168 metres north of St. Clair Avenue West to a point 5.5 metres further north; and no parking anytime from a point 56.5 metres north of Norman Avenue to a point 5.5 metres further north

E. By inserting in Part A (12:01 a.m. to 7:00 a.m.) in Schedule XXVI (No Standing) in § 400-79, the following in alphabetical order by street name:

McRoberts Avenue	Even	From a point 43 metres north of St. Clair Avenue West to a point 83 metres south of Rogers Road	59	All times, except no parking anytime from 168 metres north of St. Clair Avenue West to a point 5.5 metres further north; and no parking anytime from a point 56.4 metres north of Norman Avenue to a point 5.5 metres further north
