**CITY OF TORONTO**

**BY-LAW No. 819-2002**

**To amend Chapter 910, Parking Machines, of the City of Toronto Municipal Code regarding parking machines on certain streets within the City of Toronto.**

The Council of the City of Toronto HEREBY ENACTS as follows:

- Schedule I to Chapter 910, Parking Machines, of the City of Toronto Municipal Code, as amended, is further amended by striking out the following words and figures where they occur opposite each other in Columns 1, 2, 3, 4, 5 and 6 of the said Schedule:
