**CITY OF TORONTO**

**BY-LAW No. 879-2002**

**To amend By-law No. 2958-94 of the former City of York, being a By-law “To regulate traffic on City of York Roads”.**

The Council of the City of Toronto HEREBY ENACTS as follows:

NO PARKING - SCHEDULE VIII

1. That Schedule VIII of former City of York By-law No. 2958-94, as amended, be further amended by deleting in Columns 1, 2, 3 and 4 of said Schedule the following:

<u>Column 1 Highway</u>	<u>Column 2 Side</u>	<u>Column 3 Between</u>	<u>Column 4 Prohibited Times or Days</u>
Brookside Avenue	West	A point 18.3 metres north of St. John’s Road and a point 6.0 metres north thereof	Anytime
Clouston Avenue	North	Weston Road and a point 32 metres east thereof	Anytime

SCHEDULE X - PARKING FOR RESTRICTED PERIODS

2. That Schedule X of former City of York By-law No. 2958-94, as amended, be further amended by deleting in Columns 1, 2, 3, 4 and 5 of said Schedule the following:

<u>Column 1 Highway</u>	<u>Column 2 Side</u>	<u>Column 3 Between</u>	<u>Column 4 Prohibited Times or Days</u>	<u>Column 5 Period Permitted</u>
Clouston Avenue	North	A point 32 metres east of Weston Road and a point 78 metres east thereof	8:00 a.m. to 7:00 p.m.	60 Min.

NO PARKING – SCHEDULE VIII

3. That Schedule VIII of former City of York By-law No. 2958-94, as amended, be further amended by inserting in Columns 1, 2, 3 and 4 of said Schedule the following:

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>Side</u>	<u>Column 3</u> <u>Between</u>	<u>Column 4</u> <u>Prohibited</u> <u>Times or Days</u>
Clouston Avenue	North	Weston Road and a point 43 metres east thereof	Anytime

SCHEDULE X – PARKING FOR RESTRICTED PERIODS

4. That Schedule X of former City of York By-law No. 2958-94, as amended, be further amended by inserting in Columns 1, 2, 3, 4 and 5 of said Schedule the following:

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>Side</u>	<u>Column 3</u> <u>Between</u>	<u>Column 4</u> <u>Prohibited</u> <u>Times or Days</u>	<u>Column 5</u> <u>Period</u> <u>Permitted</u>
Clouston Avenue	North	A point 43 metres east of Weston Road and a point 67 metres east thereof	8:00 a.m. to 7:00 p.m.	60 Min.
