BY-LAW No. 896-2002

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,
respecting Beatrice Street and Huron Street.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

Beatrice Street	East	College Street and a point 54 metres south thereof	Anytime
Beatrice Street	West	College Street and a point 61 metres south thereof	Anytime
Huron Street	East	A point 95.5 metres north of Lowther Avenue and a point 23 metres further north	9:00 a.m. to 3:30 p.m. and 4:00 p.m. to 5:00 p.m., Mon. to Fri.

B. By inserting in Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)
Huron Street	East	A point 95.5 metres north of Lowther Avenue and a point 87.0 metres further north	9:30 a.m. to 11:30 a.m., and 1:30 p.m. to 3:30 p.m., Mon. to Fri.

C. By inserting in Schedule XXIV (No Stopping) in § 400-77, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)
Beatrice Street	East	College Street and a point 54 metres south thereof	Anytime
Beatrice Street	West	College Street and a point 61 metres south thereof	Anytime

D. By deleting from Schedule XXV (Time Limit Parking) in § 400-78, the following in alphabetical order by street name:

Huron Street	East	A point 95.5 metres north of Lowther Avenue and a point 23 metres further north	8:30 a.m. to 9:00 a.m. and from 3:30 p.m. to 4:00 p.m., Mon. to Fri.	10 mins.

E. By inserting in Schedule XXV (Time Limit Parking) in § 400-78, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)	(In Column 5)
Huron Street	East	A point 95.5 metres north of Lowther Avenue and a point 87.0 metres further north	8:00 a.m. to 9:30 a.m., 11:30 a.m. to 1:30 p.m., and 3:30 p.m. to 5:00 p.m., Mon. to Fri.	10 mins.
