CITY OF TORONTO

BY-LAW No. 1046-2002

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Boothroyd Avenue, Colborne Street and Mill Street.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Schedule I (One-Way Highways) in § 400-54, the following in alphabetical order by street name:

| (From Column 1) | (From Column 2) | (From Column 3) | (From Column 4) |
|--------------------|---|--------------------|--------------------|
| Colborne Street | A point 33 metres west of Victoria Street and Victoria Street | Anytime | From west to east |

B. By inserting in Schedule I (One-Way Highways) in § 400-54, the following in alphabetical order by street name:

| (In Column 1) | (In Column 2) | (In Column 3) | (In Column 4) |
|------------------|--|------------------|-------------------|
| Colborne Street | Yonge Street and Victoria Street/Scott Street | Anytime | From east to west |

C. By inserting in Schedule IV (Stop Intersections) in § 400-57, the following in alphabetical order by street name:

| (In Column 1) | (In Column 2) |
|-------------------------------------|--|
| Boothroyd Avenue and Boulton Avenue | Boothroyd Avenue (southbound) |
| Mill Street and Trinity Street | Mill Street (eastbound and westbound) |

D. By deleting from Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

| (From Column 1) | (From Column 2) | (From Column 3) | (From Column 4) |
|--------------------|--------------------|-------------------------------|--------------------|
| Colborne Street | South | Yonge Street and Scott Street | Anytime |

E. By inserting in Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

| (In Column 1) | (In Column 2) | (In Column 3) | (In Column 4) |
|--------------------|------------------|---|------------------|
| Colborne Street | South | A point approximately 60 metres east of Yonge Street and Victoria Street/Scott Street | Anytime |
| Colborne Street | South | Yonge Street and a point approximately 30 metres east thereof | Anytime |
| Mill Street | North | A point 40 metres west of Cherry Street and a point 11 metres further west | Anytime |
| Mill Street | North | A point 130 metres west of Cherry Street and a point 11 metres further west | Anytime |

F. By inserting in Schedule XXIV (No Stopping) in § 400-77, the following in alphabetical order by street name:

| (In Column 1) | (In Column 2) | (In Column 3) | (In Column 4) |
|--------------------|------------------|---|------------------|
| Colborne Street | South | A point approximately 30 metres east of Yonge Street and a point approximately 60 metres east of Yonge Street | Anytime |
