### BY-LAW No. 1086-2002

# To amend City of Toronto Municipal Code Chapter 849, Water and Sewage Services, respecting water rates.

WHEREAS it is necessary and appropriate for the City of Toronto to set and harmonize water and sewer rates;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Section 849-15 of Chapter 849, Water and Sewage Services, Rates, Consumers in former Borough of East York, is amended by adding the following two columns to the right side of the chart contained therein:

- 5. Section 849-19 of Chapter 849, Water and Sewage Services, Rates, Consumers in former City of Toronto, is amended by adding thereto the following:
  - F. Commencing January 1, 2003, in respect of water accounts not paid before the Due Date, metered consumers shall pay a combined Water Rate and Sewer Service Rate of \$1.3426 per cubic metre of water used or fraction thereof, or \$6.1033 per 1000 imperial gallons or fraction thereof.
  - G. Commencing January 1, 2003 in respect of water accounts paid on or before the Due Date, metered consumers shall pay a combined Water Rate and Sewer Service Rate of \$1.2754 per cubic metre of water used or fraction thereof, or \$5.7981 per 1000 imperial gallons or fraction thereof.

H. Commencing April 1, 2003, metered consumers shall pay a combined water rate and sewer service rate based on the volume of water consumed, date of consumption and date of payment of the water rate in relation to the due date, as set out in the following chart:
