BY-LAW No. 1099-2002

To amend further By-law No. 181-81 of the former Municipality of Metropolitan Toronto and to amend amending By-law No. 604-2001.

WHEREAS By-law No. 181-81 of the former Municipality of Metropolitan Toronto, a by-law "To provide pensions and death benefits to members of the Metropolitan Police Force", as heretofore amended, governs the Metropolitan Toronto Police Benefit Fund; and

WHEREAS it is desired to amend said By-law No. 181-81 so as to remove, because of inconsistency with subsequent improvements in spousal survivor benefits, the original transitional provisions for such benefits arising from pre-1980 retirements, to correct clerical errors in the wording of the provisions for pensioner increases for the year 1998, to re-express the basic pensioner increase for the year 2002 as a specific percentage, to provide for recommencement, at a reduced level, of contributions in the year 2003, and to provide for cost-of-living increases for certain pensioners as of January 1, 2003, and to amend amending By-law No. 604-2001 by deleting an erroneously worded amending provision therein respecting the said 1998 increases;

The Council of the City Toronto HEREBY ENACTS as follows:

- **1.** In this by-law,
 - (a) "By-law No. 181-81" means By-law No. 181-81 of the former Municipality as heretofore amended;
 - (b) "former Municipality" means The Municipality of Metropolitan Toronto.
- 2. (1) Subsection 30(2) of By-law No. 181-81 is repealed.
 - (2) Clause 3(2)(b) of By-law No. 604-2001, a by-law "To amend By-law No. 181-81 of the former Municipality of Metropolitan Toronto", which modified, effective as of June 5,1998, subsection 32s(1) (as enacted by By-law No. 278-1998 and subsequently amended by By-law No. 375-1999) of By-law No. 181-81, is repealed.
 - (3) Subsection 32s(1) of By-law No. 181-81, as such subsection was enacted by By-law No. 278-1998 and amended by By-law No. 375-1999, is further amended by striking out the opening text, "Save and except for those pensions increased pursuant to subsection (2), and subject" and substituting therefor "Subject".

- (4) Subsection 32v(1) of By-law No. 181-81 as enacted by By-law No. 604-2001 is amended by striking out the text "not in excess of 6 per cent." in the two lines immediately following clause (b) thereof and substituting therefor "being 2.62 per cent".
- **3.** Section 8 of By-law No. 181-81, as heretofore amended, is further amended by adding thereto the following subsection (1.2):

4. By-law No. 181-81 is further amended by adding thereto the following section:

is hereby increased by the percentage pension increase provided for in subsection (1) multiplied by the adjustment factor set out opposite such date in Column II:

- 5. (1) Subject to subsections (2) to (4), this by-law shall come into force on the date of its enactment and passing.
 - (2) Subsection 2(1) shall be deemed to have come into force on the 1st day of July, 1994.

- (3) Subsections 2(2) and (3) shall be deemed to have come into force on the 5th day of June, 1998.
- (4) Subsection 2(4) shall be deemed to have come into force on the 1st day of January, 2002.
