BY-LAW No. 82-2004

**To amend further Metropolitan By-law No. 32-92, respecting the regulation of traffic on
former Metropolitan Roads, regarding Bayview Avenue, Dundas Street East,
Kingston Road and Yonge Street.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Schedule IV (Stands for Taxicabs) of Metropolitan By-law No. 32-92, as amended, is further amended by striking out the following words and figures where they occur opposite each other in Columns 1, 2, 3, 4 and 5 of the said Schedule:
