**CITY OF TORONTO**

**BY-LAW No. 97-2004**

**To amend City of Toronto Municipal Code Chapter 19, Business Improvement Areas, to include the new Knob Hill Plaza Business Improvement Area and to establish a Board of Management for the Knob Hill Plaza Business Improvement Area.**

WHEREAS Council, at its meeting held on February 4, 5 and 6, 2003 by its adoption of Clause No. 12 of Economic Development and Parks Committee Report No. 2, authorized the designation of an area on the south side of Eglinton Avenue from Falmouth Avenue to just west of Brimley Road as a business improvement area under section 220 of the former *Municipal Act*; and

WHEREAS by the adoption of Clause No. 3 of Economic Development and Parks Committee Report No. 1 on January 27, 28 and 29, 2004, City of Toronto Council established a board of management for the Knob Hill Plaza Business Improvement Area and appointed members to the Knob Hill Plaza Business Improvement Area Board of Management for a term expiring on November 30, 2006, or as soon thereafter as successors are appointed; and

WHEREAS Schedule A of the City of Toronto Municipal Code Chapter 19, Business Improvement Areas, must be amended to include the new Knob Hill Plaza Business Improvement Area Board of Management;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. The City of Toronto Municipal Code Chapter 19, Business Improvement Areas, is amended as follows:
  - A. The table in Schedule A, Boards of Management is amended by adding the new Knob Hill Plaza Board of Management as set out in Schedule A attached;
  - B. Schedule A, Maps is amended by adding the attached maps of the Knob Hill Plaza Business Improvement Area; and
  - C. The table in § 19-2 is amended by inserting in the first column "46-2003" and by inserting in the third column "Knob Hill Plaza".

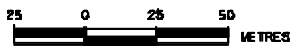
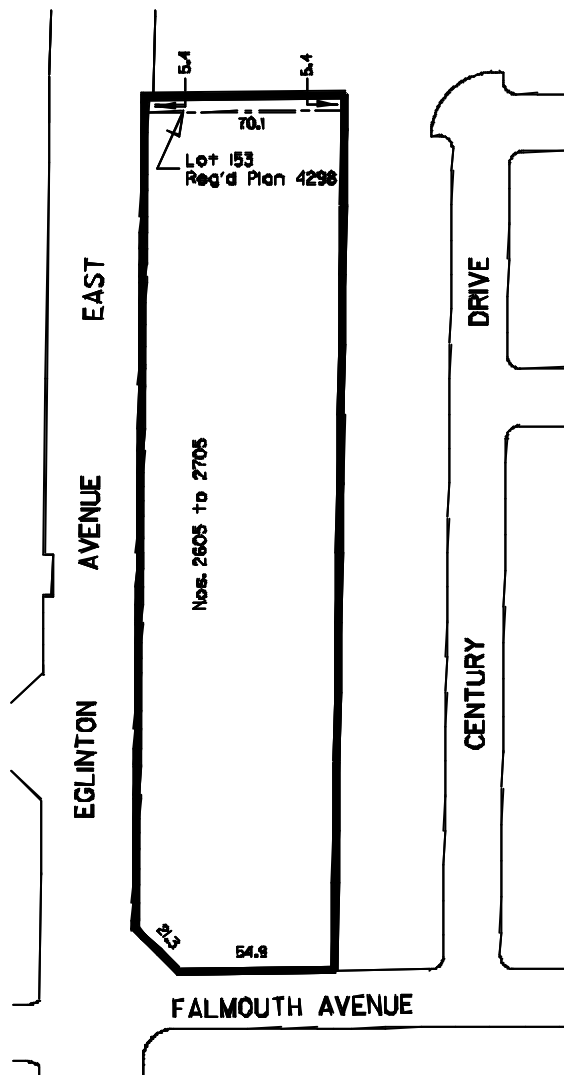
