## **CITY OF TORONTO**

### **BY-LAW No. 98-2004**

#### **To amend City of Toronto Municipal Code Chapter 19, Business Improvement Areas, to make changes to the size of various Business Improvement Area Boards of Management.**

WHEREAS Chapter 19, Business Improvement Areas of the City of Toronto Municipal Code designates various areas of the City as Business Improvement Areas; and

WHEREAS by the adoption of Clause No. 3 of Report No. 1 of the Economic Development and Parks Committee on January 27, 28 and 29, 2004, City of Toronto Council approved the appointment of members to various Business Improvement Area Boards of Management for a term expiring on November 30, 2006, or as soon thereafter as successors are appointed and the removal of some members from some Boards of Management; and

WHEREAS Schedule A of the Toronto Municipal Code, Chapter 19, Business Improvement Areas must be amended to reflect the change in the number of members of the various Business Improvement Area Boards of Management;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. The table in Schedule A of the Toronto Municipal Code, Chapter 19, Business Improvement Areas, is hereby amended as follows:
  - (1) by changing the number of members of the Bloor By the Park Business Improvement Area from 8 to 9 members;
  - (2) by changing the number of members of the Bloorcourt Village Business Improvement Area from 12 to 10, and the number required for quorum from 6 to 5;
  - (3) by changing the number of members of the Bloordale Village Business Improvement Area from 8 to 9, and the number required for quorum from 4 to 5;
  - (4) by changing the number of members of the Bloor-Yorkville Business Improvement Area from 20 to 13, and the number required for quorum from 10 to 6;
  - (5) by changing the number of members of the Church-Wellesley Village Business Improvement Area from 17 to 15, and the number required for quorum from 8 to 6;

- (6) by changing the number of members of The Danforth Business Improvement Area from 14 to 12;
- (7) by changing the number of members of the Dovercourt Village Business improvement Area from 8 to 7, and the number required for quorum from 4 to 3;
- (8) by changing the number of members of the Eglinton Hill Business Improvement Area from 7 to 9, and the number required for quorum from 4 to 5;
- (9) by changing the number of members of the Eglinton Way Business Improvement Area from 12 to 7, and the number required for quorum from 6 to 4;
- (10) by changing the number of members of the Forest Hill Village Business Improvement Area from 6 to 9, and the number required for quorum from 3 to 6;
- (11) by changing the number of members of the Gerrard India Bazaar Business Improvement Area from 20 to 16, and the number required for quorum from 10 to 7;
- (12) by changing the number of members of the Greektown on the Danforth Business Improvement Area from 17 to 12, and the number required for quorum from 8 to 5;
- (13) by changing the number of members of the Harbord Street Business Improvement Area from 8 to 9;
- (14) by changing the number of members of the Hillcrest Village Business Improvement Area from 7 to 9, and the number required for quorum from 3 to 4;
- (15) by changing the number of members of the Junction Gardens Business Improvement Area from 10 to 12, and the number required for quorum from 5 to 6;
- (16) by changing the number of members of the Kennedy Road Business Improvement Area from 15 to 13;
- (17) by changing the number of members of the Lakeshore Village Business Improvement Area from 8 to 10, and the number required for quorum from 4 to 5;
- (18) by changing the number of members of the Liberty Village Business Improvement Area from 17 to 18;
- (19) by changing the number of members of the Little Italy Business Improvement Area from 7 to 6, and the number required for quorum from 4 to 3;
- (20) by changing the number of members of the Long Branch Business Improvement Area from 10 to 7, and the number required for quorum from 5 to 4;

- (21) by changing the number of members of the Mimico by the Lake Business Improvement Area from 9 to 7 and the number of Councillors from 2 to 1;
- (22) by changing the number of members of the Mimico Village Business Improvement Area from 10 to 5, the number of Councillors from 2 to 1, and the number required for quorum from 4 to 3;
- (23) by changing the number of members of the Old Cabbagetown Business Improvement Area from 11 to 13;
- (24) by changing the number of members of the Parkdale Village Business Improvement Area from 11 to 14, and the number required for quorum from 6 to 7;
- (25) by changing the number of members of the Queen/Broadview Village Business Improvement Area from 17 to 11, and the number required for quorum from 9 to 5;
- (26) by changing the number of members of the Rosedale-Summerhill Business Improvement Area from 11 to 12;
- (27) by changing the number of members of the St. Clair Avenue West Business Improvement Area from 6 to 7;
- (28) by changing the number of members of the St. Clair Gardens Business Improvement Area from 7 to 8;
- (29) by changing the number of members of the St. Lawrence Market Neighbourhood Business Improvement Area from 8 to 13, and the number required for quorum from 4 to 6;
- (30) by changing the number of members of The Kingsway Business Improvement Area from 9 to 11, and the number required for quorum from 5 to 6;
- (31) by changing the number of members of the Village of Islington Business Improvement Area from 7 to 9, and the number required for quorum from 4 to 5;
- (32) by changing the number of members of the Weston Business Improvement Area from 15 to 12, and the number required for quorum from 8 to 7;
- (33) by changing the number of members of the Yonge-Lawrence Business Improvement Area from 10 to 11, and the number of Councillors from 2 to 1; and

- (34) by changing the number of members of the York-Eglinton Business Improvement Area from 10 to 18, and the number of Councillors from 2 to 1.
