CITY OF TORONTO

BY-LAW No. 117-2004

To amend City of Toronto Municipal Code Chapter 545, Licensing, respecting the establishment of administrative thresholds for the issuance of business licenses.

WHEREAS Section 150 of the *Municipal Act*, 2001, grants local municipalities the authority to license, regulate and govern any business wholly or partly carried on within the municipality for purposes of health and safety and consumer protection; and

The Council of the City of Toronto HEREBY ENACTS as follows:

- 1. Chapter 545, Licensing, of the City of Toronto Municipal Code is amended as follows:
 - A. By deleting the reference to "Subsection C" in Subsection 545-4B(1)(a) and replacing it with "Subsections C and C.1".
 - B. By adding the following subsection C.1 to § 545-4:
 - C.1 Administrative thresholds for denial of licence.

In addition to the grounds set out in subsection C of this section, the Municipal Licensing and Standards Division shall, with respect to applications received on or after July 1, 2004, refuse the issuance or renewal of a licence where an applicant has not met the business licensing thresholds as set out in Appendix K to this chapter.

- C. By adding the following subsection to § 545-5:
 - M. Any licensee who in the course of the tenure of his or her licence ceases to comply with the business licensing thresholds contained in Appendix K to this chapter shall immediately contact and advise the Municipal Licensing and Standards Division of the nature and extent of the violation, and failure to provide such notice may independently result in the suspension of the licence-holder's licence.
- D. By adding the following to the end of § 545-6A:

For greater certainty, the Toronto Licensing Tribunal shall not be bound by the business licensing thresholds as set out in Appendix K to this chapter, provided that the Toronto Licensing Tribunal shall be required to report, within a reasonable period of time, to the appropriate Community Council with respect to stationary licenses, or to the Planning and Transportation Committee with respect to mobile or trades licences, setting out the basis for:

- (1) A decision to issue or renew a licence refused by the Municipal Standards and Licensing Division for failure to comply with Subsection 545-4C.1; or
- (2) A decision not to attach conditions, revoke or suspend a licence as recommended by Municipal Standards and Licensing Division for failure to comply with the business licensing thresholds as set out in Appendix K to this chapter.
- E. By deleting Subsection 545-6B and substituting the following:

The Municipal Licensing and Standards Division may refer to the Toronto Licensing Tribunal for a hearing any matter in respect of which a licence may be refused, suspended, revoked or have conditions imposed on it pursuant to this chapter, which shall include the failure by a licensee to comply with the business licensing thresholds as set out in Appendix K to this chapter.

- F. By adding the business licensing thresholds attached as Schedule "A" to this by-law as Appendix K to the chapter.
- 2. This by-law shall come into force on July 1, 2004.

APPENDIX K TO CH. 545 BUSINESS LICENSING THRESHOLDS

Group No. 1:

Licences:

taxicab driver, taxicab owner, limousine driver, limousine owner, catering truck driver, catering truck owner, driving school instructor, driving school owner, tow truck driver, tow truck owner, horse drawn carriage operator, hot dog cart operator, rickshaw/pedicab operator

- 1-A. Issuance/renewal is to be denied, if the applicant has:
 - (i) any criminal offence convictions involving minors;
 - (ii) any restriction code 01 convictions within the last 10 years;
 - (iii) any restriction code 02 convictions within the last two years;
 - (iv) two or more restriction code 02 convictions within the last five years;
 - (v) any restriction code 04 or 05 convictions within the last year;
 - (vi) three or more restriction code 04 or 05 convictions, or combinations thereof, within the last five years;
 - (vii) any restriction code 06 convictions within the last two years;
 - (viii) three or more restriction code 07 convictions within the last year;
 - (ix) accumulated six or more by-law and related* convictions concerning the operation of the business or any prior business within the last year; or
 - (x) overdue by-law fines exceeding \$500.
- 1-B. Recommendation to the Toronto Licensing Tribunal to suspend a licence is to be made, if during the current tenure of the licence the applicant is:
 - (i) convicted of any criminal offence charges involving minors;
 - (ii) convicted of any restriction code 01 charges;
 - (iii) convicted of any restriction code 02 charges;
 - (iv) convicted of any restriction code 04 or 05 charges, or combination thereof;
 - (v) convicted of any restriction code 06 charges;
 - (vi) convicted of any restriction code 07 charges;
 - (vii) convicted of six or more by-law and related* charges concerning the operation of the business or any prior business within the last year; or
 - (viii) owing overdue by-law fines exceeding \$500.
- 1-C. Recommendation to the Toronto Licensing Tribunal to issue/renew a licence with conditions is to be made, if the applicant has:
 - (i) any restriction code 01 convictions more than ten years old;
 - (ii) two or more restriction code 02 convictions in the last ten years;
 - (iii) three or more restriction code 04 or 05 convictions, or combination thereof, within the last ten years;

- (iv) accumulated nine or more demerit points (as defined in the HTA) within the last year;
- (v) accumulated four or more by-law and related* convictions concerning the operation of the business or any prior business within the last year; or
- (vi) two restriction code 07 convictions within the last year.

Group No. 2:

Licences: adult entertainment parlours, burlesque entertainers, body rub parlours, body rub attendants, massage parlours, holistic centres and practitioners, public bath houses

- 2-A. Issuance/renewal is to be denied, if the applicant has:
 - (i) any criminal offence convictions involving minors;
 - (ii) any restriction code 01 convictions within the last 10 years;
 - (iii) any restriction code 02 convictions within the last two years;
 - (iv) two or more restriction code 02 convictions within the last five years;
 - (v) any restriction code 03 or 05 convictions, or combination thereof, within the last year;
 - (vi) three or more restriction code 03 or 05 convictions within the last five years;
 - (vii) three or more restriction code 07 convictions within the last year;
 - (viii) accumulated six or more by-law and related* convictions concerning the operation of the business or any prior business within the last year; or
 - (ix) overdue by-law fines exceeding \$500.

 - (v) any restriction code 03 convictions within the last year;
 - (vi) three or more restriction code 03 convictions within the last five years;
 - (vii) three or more restriction code 07 convictions within the last year;
 - (viii) accumulated six or more by-law and related* convictions concerning the operation of the business or any prior business within the last year; or
 - (ix) overdue by-law fines exceeding \$500.

 - (ix) overdue by-law fines exceeding \$500.
