BY-LAW No. 119-2004

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,
respecting Cumberland Street.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

(From Column 1)	(From Column 2)	(From Column 3)	(From Column 4)
Cumberland Street	North	Avenue Road and Bellair Street	Anytime
Cumberland Street	South	A point 45 metres east of Avenue Road and Bellair Street	Anytime

B. By inserting in Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)
Cumberland Street	North	A point 60 metres east of Avenue Road and a point 99 metres further east	Anytime
Cumberland Street	North	A point 159 metres east of Avenue Road and a point 49 metres further east	6:00 a.m. to 6:00 p.m., Mon. to Fri.
Cumberland Street	North	A point 220 metres east of Avenue Road and a point 15 metres west of Bellair Street	6:00 a.m. to 6:00 p.m., Mon. to Fri.

C. By deleting from Schedule XXIV (No Stopping) in § 400-77, the following in alphabetical order by street name:

(From Column 1)	(From Column 2)	(From Column 3)	(From Column 4)
Cumberland Street	North	A point 60 metres east of Avenue Road and a point 100 metres east of Avenue Road	7:30 a.m. to 9:30 p.m. and 3:30 p.m. to 6:30 p.m., Mon. to Fri.
Cumberland Street	South	Avenue Road and a point 100 metres east	Anytime

D. By inserting in Schedule XXIV (No Stopping) in § 400-77, the following in alphabetical order by street name:

Cumberland Street	North	A point 60 metres east of Avenue Road and a point 99 metres further east	7:30 a.m. to 9:30 a.m. and 3:30 p.m. to 6:30 p.m., Mon. to Fri.
Cumberland Street	South	Avenue Road and Bellair Street	Anytime

E. By deleting from Schedule XXIX (No Standing) in § 400-82, the following in alphabetical order by street name:

(From Column 1)	(From Column 2)	(From Column 3)	(From Column 4)
Cumberland Street	South	Avenue Road and a point 45 metres east thereof	Anytime

F. By inserting in Schedule XXXVIII (Designated On-Street Parking for Disabled Person Parking Permit Holders) in § 400-91, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)
Cumberland Street	North	A point 208 metres east of Avenue Road and a point 12 metres further east	Anytime
