BY-LAW No. 136-2004

To amend further By-law No. 20-96, a by-law “To provide for overnight permit parking on Borough streets”, being a by-law of the former Borough of East York, regarding Frankdale Avenue, Inwood Avenue and Wiley Avenue.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Schedule B of By-law No. 20-96, entitled “To provide for overnight permit parking on Borough streets”, as amended, being a by-law of the former Borough of East York, is further amended by deleting the following words and figures where they appear opposite each other in Columns 1, 2, 3, 4, 5 and 6 of the said Schedule:
