**CITY OF TORONTO**

**BY-LAW No. 160-2004**

**To amend By-law No. 31001 of the former City of North York, as amended, regarding  
Beecroft Road and Rippleton Road.**

The Council of the City of Toronto HEREBY ENACTS as follows:
